ELECTION NOTIFICATION

Chairman Bamboo society of India, Bangalore has authorized me as an election officer, in his letter wide No.BSI/KC-Election/689/20-21 dated24.12.21to conduct an election/nomination to the management committee of the Karnataka state chapter of the bamboo society of India.

- 1. As per the office memorandum issued by the chairman bamboo society of India, vide number No./guidelines/sc-670/2021 dated 13.1.2021, ref. clause 2. the state chapter shall have 7 members in the managing committee, either elected /nominated. Among the seven members of the elected in the managing committee, they shall elect 4 office bearers namely Director, Associated Director, secretary, and treasurer, three members shall be in the state managing committee.
- 2. The Elections will be conducted by secret ballot paper voting and the designated place for voting is at the BSI head office, Bengaluru.
- 3. Election notification with a calendar of events is being sent to all the eligible members of the Karnataka state chapter by email, post, under certificate of postings/registered post, or courier.
- 4. The members may download the election notification from the website of BSI, <u>www.bamboosocietyofindia.in</u>
- 5. Eligible members of the Bamboo Society of India Karnataka chapter normally are the residents of the state of Karnataka, and who wish to contest in the election for the Karnataka state management committee of Bamboo Society of India, Bengaluru can download Nomination Forms from the BSI website or obtain the nomination forms from the Election Officer o/o. Bamboo Society of India, Vanavikas building, Malleswaram, Bengaluru for contesting in the above elections.

- 6. The contesting candidates shall file properly filled up nomination forms affixing passport size photo to the Election Officer in person or online enclosing DD or pay order/online payment for Rs. 2000/- in favor of Bamboo Society of India payable at Bengaluru as election deposit within the due date with all particulars such as the membership number of BSI, serial no. of the candidate in the voters' list, copy of the Adhaar card, two passport size photos, Email ID, mobile number, bank account details of the contesting candidate. Upon withdrawal of the nomination, if any caused, the election deposit paid will be refunded within 15 days from the date of an election.
- 7. Members representing any organization/ Institution/corporate bodies who are willing to contest in the election shall produce the authorization letter duly signed by the head of the Organization / Institution / Corporate body or General Power of Attorney authorizing him/her to contest/participate in any of such elections of Karnataka state chapter of BSI.
- 8. Individual names of the contestants will appear in the secret ballot papers in a single horizontal row with their photos on the day of the election.
- 9. The Election Officer will oversee/supervise the election and secret ballot paper voting system at BSI, (HQ) Bengaluru.
- 10. The final eligible voter's list of the Karnataka chapter of BSI will be published on the website of BSI.

The calendar of events for conducting election secret ballot paper voting is as below:

Commencing date for filing duly filled Nomination: 07.05.2022 Forms affixing passport size photo along with membership number of BSI, serial no. of the candidate in the voter's list, 2 passport size photos, copy of the Adhaar card, Email ID, mobile no., bank a/c details & the election deposit by online, submit DD/Pay order in person to the o/o the bamboo society of India (HQ) or into the account number of Bamboo Society of India, Vanavikas building, Malleswaram, Bengaluru-560003.

C. Scrutiny of the nomination papers by the Election : 10.05.2022 Officer.

E. Declaration of the final list of the contestants by : 13.05.2022 the Election Officer

F. Date and time of the commencement of election by E-secret ballot paper voting : 18.05.2022 8.00 AM -5.00 PM.

- 11. Each eligible member of the Karnataka chapter of BSI is entitled to cast 7 votes out of the list appearing in the secret ballot paper for the selection of 7 state managing committee members to the Karnataka chapter of BSI, Bengaluru.
- 12. The secret ballot paper voting shall remain open for one day only and shall close at 5.00 pm on the same day.
- 13. The Election results will be declared by the Election Officer based on the actual count of the secret ballot votes polled.
- 14. The list of elected/selected candidates will be made available to the contesting candidates to the Karnataka state chapter of the Bamboo Society of India.

15. A special meeting of newly elected members will be held on 21.05.2022 at 11.00 AM at BSI (Hq.) to elect/select/nominate the Director, Associate Director, Secretary, and Treasurer of the Karnataka state management committee of the Bamboo Society of India, Bengaluru, and will be the only agenda of the meeting. The meeting will be held under the interim Chairman (or outgoing chairman). The names of the new office bearers will be declared by the interim Chairman who will invite the newly elected office bearers to assume charge of the Karnataka state management committee of the Bamboo Society of India.

The election for new office bearers of the Karnataka state management committee of the Bamboo Society of India. will be recorded and minutes will be signed by the interim Chairman, submit a copy to the chairman bamboo society of India.
