## **PREAMBLE**

Dr. Sruthi Subbanna, a member of the Governing Council (GC) was working as Secretary-cum-Treasurer of Bamboo Society of India. Due to her compelling engagements and personal circumstances, she resigned from this post on 29.08.2023. In the absence of alternate arrangements, this responsibility is being handled by the Executive Director temporarily.

The BSI byelaws were amended in April 2024. As per the amended byelaws there is a position of Secretary of BSI. There is also an independent treasurer position. The revised byelaws specify the roles and responsibilities of these two positions. The workload at BSI is increasing. So, it has become necessary to fill up these two posts.

The GC, in its meeting held on 24.052024 discussed the matter and resolved to accept the resignation of Dr. Sruthi Subbanna and appoint Sri. Parameswaran Krishna Iyer, GC member as the Secretary with immediate effect.

Considering the need to have the Treasurer stationed in Bengaluru for day- to-day bank operations, available GC members living in Bengaluru were sounded to take up the responsibility of Treasurer. No one was ready: Considering the independent position of the Treasurer as a newly created post and considering the need to have a Bengaluru-based member as a Treasurer, it has been resolved to appoint Sri. Paramashivaiah as the Treasurer in accordance with the byelaws No. 7.4 for the remaining tenure of the GC. Hence, the following notification.

- 1. The resignation tendered by Dr. Sruthi Subbanna to the post of Secretary cum Treasurer, is here by accepted. She will continue to be a GC member.
- 2. Sri. Parameswaran Krishna Iyer, GC member has been appointed as the Secretary of BSI with immediate effect. He shall discharge the duties and responsibilities laid down in the revised byelaws No. 8.4.2.
- 3. Sri. Paramashivaiah is appointed as the Treasurer of BSI with immediate effect and until further orders. He shall discharge the duties and responsibilities laid down in the revised byelaws No. 8.5.2.
